#### ORDER

1. The University had invited application for Continuation of Provisional Affiliation for the academic year 2024-25 vide read paper (1) above. Accordingly, Principals of all the Pharmacy Colleges submitted application for Continuation of Provisional Affiliation for the academic year 2024-25 with required fee. Then, the University, conducted an inspection in the colleges.

2. The Scrutiny Committee after verifying the inspection reports that received in the University after inspection, recommended to grant Continuation of Provisional Affiliation to 24 Pharmacy Colleges mentioned in the table A as no deficiencies were reported on the colleges.

4. The Governing Council, vide paper read (2) above, resolved to grant Continuation of Provisional Affiliation to the Pharmacy colleges mentioned in Table A and Table B to the courses for which the intake is recommended against, for the academic year 2024-25 subject to the approval of the Pharmacy Council of India.

In these circumstances, Sanction is hereby accorded to grant Continuation of Provisional Affiliation to the 25 Pharmacy Colleges mentioned in the above table A & B for the academic year 2024 - 25 subject to the approval of the Pharmacy Council of India.

The College shall strictly adhere to the following conditions:

i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.

ii) In the light of the direction of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

iii) Affiliation granted is strictly Provisional and only for the academic year 2024-25. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

iv) Admission to the next academic year shall be made only after obtaining prior permission from the University.

v) College has to remit annual administration fee fixed for UG/PG Courses during 2024-25.

vi) The colleges should submit approval order from the PCI for the year 2024-25.
