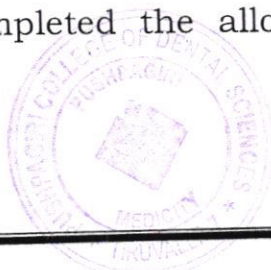

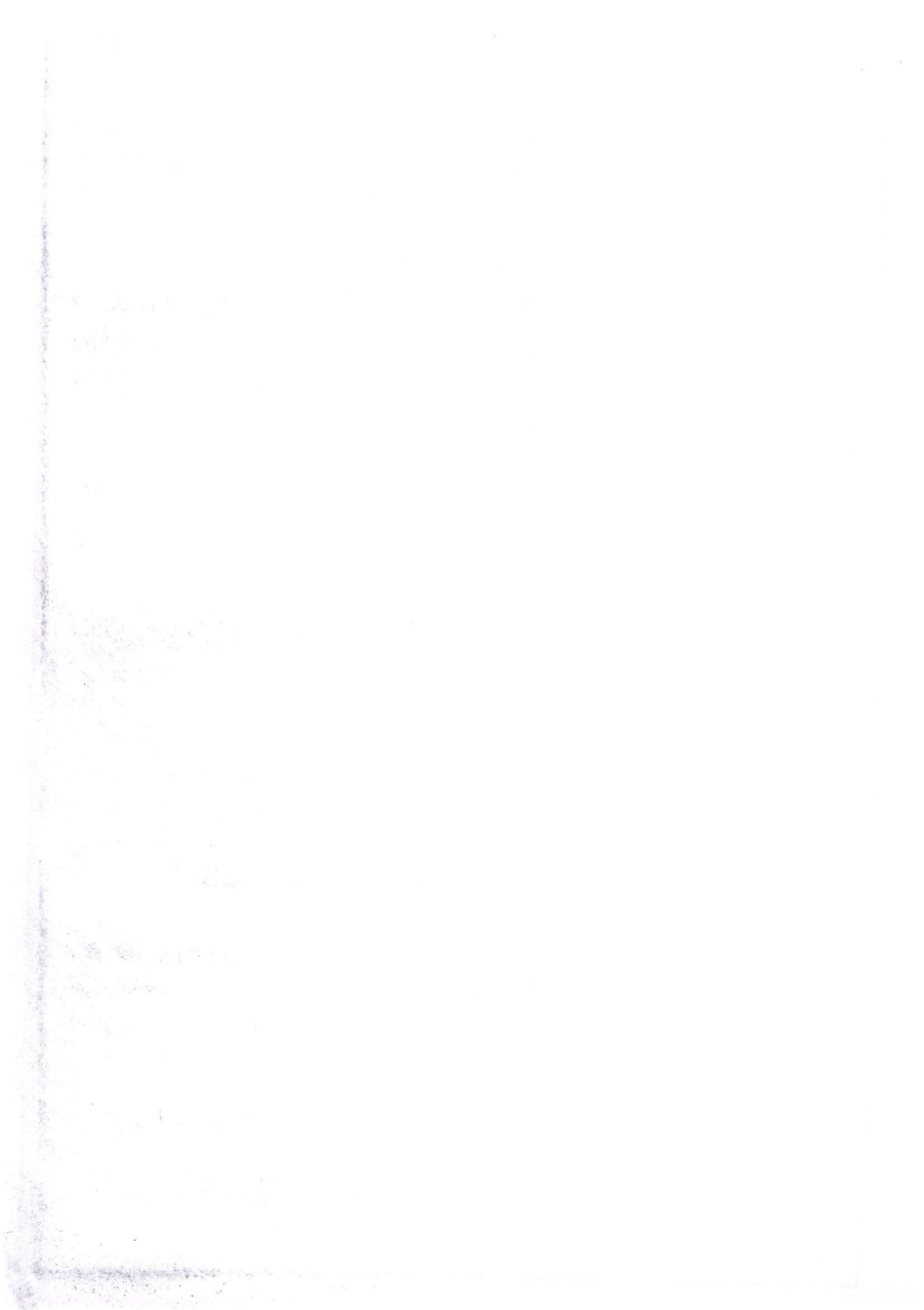
ORDER

1. The Government of Kerala by order dated 17.11.2020 has approved the seat matrix for BDS Course 2020-21 furnished by the Director of Medical Education. The Commissioner for Entrance Examination, in short the CEE, had completed the allotment process on the basis of the seat matrix

approved by the Government and through communication dated 03.03.2021 has submitted the list of candidates who have been allotted by the CEE to Self-Financing Dental Colleges for the academic year 2020-21, before the Admission Supervisory Committee, herein after referred as the Committee, for perusal and further proceedings.

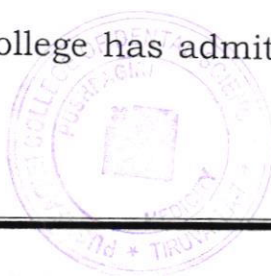
2. The Committee through communication dated 17.06.2021 has directed all the Self Financing Dental Colleges to submit the list and supporting documents of BDS admitted candidates before the Committee for approval of their admission.
3. Accordingly, the Principal, Pushpagiri College of Dental Sciences, Thiruvalla, has submitted the list and supporting documents of admitted BDS candidates before the Committee for approval.
4. The Committee has gone through the documents submitted by the Dental College and found that the Dental College is having an intake strength of 50 seats. The Dental College has submitted the letter of permission and the continuation of provisional affiliation issued by the Kerala University of Health Sciences, in short the KUHS, to conduct the BDS Course for the academic year 2020-21. The Dental College is a minority educational institution. The Dental College has also submitted the certificate issued by the National Commission for Minority Educational Institutions.
5. The Committee has gone through the seat matrix approved by the Government on 17.11.2020 and found that the Dental College was permitted to admit the candidates as per the distribution table given hereunder:-

6. The Committee scrutinised the documents submitted by the CEE and the Dental College, it is found that the Dental College has admitted Twenty Two (22) candidates under State Merit, Twenty Five (25) candidates under Minority quota belongs to Christian Community and Two (2) candidates under NRI quota, as per the online allotment conducted by the CEE. One vacant seat has been filled up by the Dental College as per direction of the CEE and as per the rank list prepared by the CEE.
7. The Committee scrutinised the documents of Twenty Two (22) candidates under State Merit quota and found that the documents of Twenty One (21) candidates are acceptable and they are eligible for BDS admission. Therefore, the admissions of Twenty One (21) candidates admitted under State Merit quota is hereby approved, as per the list shown in Annexure I.
8. On verification of the documents in respect of Ms. Rudra Shaji Hima, it is found that the above candidate was allotted under State Merit by the CEE as per the list submitted before the Committee. But the Dental College has submitted the allotment memo in respect of the above candidate, wherein it is shown that the above candidate admitted under reservation category. Therefore, the admission of the above candidate is withheld subject to the production of allotment memo issued by the CEE admitted under State Merit quota.
9. The Dental College has admitted Ms. Ann Tresa Alex under stray vacancy.

On scrutiny of the documents, it is found that the Dental College has filled up by the one vacant seat as per the direction of the CEE from the rank list. On verification of the documents in respect of the above candidate, it is also found that the entire documents are acceptable and the CEE has also included the name of the above candidate in their list as stray vacancy. Therefore, the admissions of the above candidate under Stray vacancy quota is hereby approved.

10. The Dental College has admitted Twenty Five (25) candidates under Minority category belonging to Christian Community. The Dental College has also produced the Minority Certificates obtained from the Revenue Officials to prove that the Twenty Five (25) candidates belong to Christian Community. The Committee further scrutinised the documents of candidates submitted by the Dental College and found that the documents of Twenty Four (24) Candidates are acceptable. Therefore, the admissions of the above Twenty Four (24) candidates are hereby approved under Minority quota, as per the list show in Annexure I.
11. On verification of the documents in respect of Ms. Ashitha Sibichan admitted under Minority quota, it is found that the Dental College has not submitted the NEET Score Card in respect of the above candidate. Therefore, the admission of the above candidate is withheld subject to the production of NEET Score Card.
12. The Dental College has admitted Two (2) candidates under NRI open quota. The Committee has scrutinised the entire NRI documents in respect of the above candidate and found that the admission of the above candidates are acceptable and the relationship of the sponsors with the respective candidate as per the G.O (Ms) No. 243/14/H&FWD dated 06.08.2014. The Committee has also observed that the NRI admissions are as per the guidelines issued by the Committee on various dates. Therefore, the

admissions of above candidates under NRI quota are hereby approved.

ORDER

1. The Admission Supervisory Committee, herein after referred as the Committee, through communication dated 09.01.2020 has directed the Principal, Pushpagiri College of Dental Sciences, Thiruvalla , in short the Dental College, to submit the list and supporting documents in respect of the admitted candidates of BDS Course for the academic year 2019-20, before the Committee for approval.
2. The Principal of the Dental College has submitted the above documents through Mr. Bobby Sunil Jacob, P.A to Principal of the Dental College on 29.01. 2020 on authorisation. At the time of verification of the documents in the presence of the representatives of the Dental College, the Committee pointed out the deficiencies found in the documents and directed the



representative of the Dental College to submit relevant documents for curing the defects. Accordingly, the Principal of the Dental College through communication dated 18.02.2020 has submitted entire documents to establish the right of claim of admission.

3. The Committee scrutinised the list and supporting documents and found that the Dental College is having an intake strength of Fifty (50) BDS Seats for the academic year 2019-20. The Dental College has submitted the recognition and Letter of Permission issued by the Competent Authorities to conduct the above course. The Dental College has also submitted the provisional affiliation issued by the Kerala University of Health Sciences, in short KUHS. The Dental College is having Minority Status. The representative of the Dental College has also submitted the Minority certificate obtained from the National Commission for Minority Educational Institutions.
4. The Government of Kerala through order dated 08.07.2019 has approved the Seat Matrix for admission to the BDS Course in Self Financing Dental College Educational Institutions for the academic session 2019-20. The Committee has gone through the G.O and found that the Dental College has been sanctioned Eighteen (18) seats under State Merit as per the Government reservation norms, Twenty Five (25)) seats under Minority belongs to Any Christian Community, Three (3) seats under NRI quota and Four (4) seats under NRI Minority category belongs to Any Christian Community.
5. The Committee scrutinised the list and supporting documents submitted by the Dental College and found that the Dental College has admitted Eighteen (18) seats under ~~State Merit~~ as per reservation norms, Twenty Five (25) seats under Minority quota belong to Any Christian Community and Three (3) seats under NRI quota and Four (4) candidates under NRI

Minority belong to Christian Community as per allotment made by the Commissioner for Entrance Examinations, in short the CEE.

6. The Committee scrutinised the documents of Eighteen (18) candidates admitted under State Merit quota as per the norms and found that the documents of Seventeen (17) candidates are acceptable and they are eligible for admission to BDS Course. Therefore, the admissions of the Seventeen (17) candidates admitted under State Merit quota are hereby approved, as per the list shown in Annexure I.

The Principal of the Dental College through communication dated 23.01.2019 has resubmitted the documents after rectifying the defects, as pointed out by the Committee.
4. The Admission and Fee Regulatory Committee, in short AFRC, has scrutinised the entire documents relating to the MDS Course submitted by the Dental College with the CEE registration list and KUHS Registration report. On scrutiny of the documents, the Committee found that the Dental College has admitted 10 candidates under open category and 2 candidates under NRI quota for MDS Courses in various streams during the academic year 2018-19.

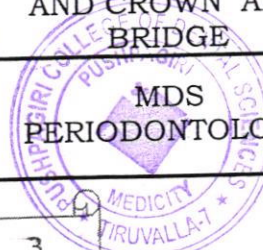

1. The Admission Supervisory Committee, in short the Committee, by order referred as 1st paper above, has withheld the admissions of 17 candidates under Minority category in respect of the Pushpagiri College of Dental Sciences, Thiruvalla, in short the Dental College, for the reason that the Dental College has not submitted community certificates issued by the revenue officials to prove that they belong to

the Minority quota category, as per the seat matrix. Therefore, the Principal of the Dental College was directed to produce the community certificates of the withheld candidates within 10 days from the date of receipt of the order.

2. Accordingly, the Director of the Dental College has submitted the community certificates in respect of the 17 candidates before the committee for approval of the admissions, as per the reference cited 2nd. paper above. The Committee scrutinised the community certificates and found that the community certificates in respect of the 5 candidates are as per the seat matrix approved by the Government. Therefore, the committee through reference cited 3rd above has approved the admissions of the 5 candidates and withheld the admissions of 12 candidates as they have not produced the proper community certificate as prescribed in the Seat Matrix.
3. The Dental College has challenged the above order of the committee before the Hon'ble High Court of Kerala in W.P (C) No. 17114 of 2019. The Hon'ble High Court through order referred as 4th paper above, has directed the petitioner college to produce the documents before the committee, to prove their eligibility for admission, if not already produced, within a period of one month from the date of order. The Court has also directed that the certificates should be from the revenue officials. On production of such certificates or with the available certificates, the committee shall consider the approval of the candidates, whose admissions have been withheld and if declining approval, pass orders showing why a particular certificate/ document with respect to an individual cannot be accepted. The Hon'ble Court has also directed the committee to complete the exercise within a



period of two months.

4. Accordingly, the Principal of the Dental College through reference cited 5th paper above, has produced certain community certificates in respect of the withheld candidates before the committee for approval. The Committee scrutinised the documents submitted by the Dental college and the communication submitted by the Dental College and found that the community certificates in respect of the 9 candidates are as per the seat matrix approved by the Government. Therefore, the admissions of the 9 candidates under Minority quota were approved as per dated 21.10.2019.
5. The Committee observed that the documents submitted by the Dental College in respect of the remaining 3 candidates were not as per the set matrix approved by the Government. Thus the Dental College had failed to prove that the admissions of the above 3 candidates under Minority quota were in accordance with the directions issued by the Hon'ble High Court. Therefore, the Committee recommended the Government to reject the admissions of the three (3) candidates under Minority quota, as per the order referred as 6th paper above. The details of the candidates are given in the Annexure I

6. After the issue of the order dated 21.10.2019, 3 students, whose admissions were recommended for rejection, appeared before the committee with their parents on 06.11.2019 and produced the required certificates issued by the Revenue Authorities. They have submitted that the students were informed about the production of the certificates only after the issue of the order dated 21.10.2019 and had they been informed of the production of the certificates, they could have obtained the same from the revenue officials and produced, in time. In fact the Principal of the College was directed to inform the students of their withheld status as per the order dated 01.04.2019. Yet the College had not complied with the above order but produced some documents instead of informing the students and the college challenged the order dated 01.04.2019 before the Hon'ble High Court in W.P (C) 12557/2019.
7. Even after the judgment in the above case, the college had not informed all the withheld students to produce the certificates and about the need to produce the certificates. In the letter dated 18.09.2019 instead of producing the certificates, the college has submitted that in case of further clarification is needed, please be kind enough to contact the Principal Secretary, Health and Family welfare and also the Commissioner for Entrance Examination in which they are also members of the committee. The indifferent and capricious approach of the college is explicit from the above passage. The admissions are made on the basis of the seat matrix furnished by

the college, which was approved by the Government. Hence, the college is bound to produce the Community certificates to suit the seat matrix. The above approach of the college is highly objectionable and has to be viewed seriously.

8. As the college had not informed the students to produce the required certificates obtained from the revenue authorities (as directed by a Division Bench of Hon'ble High Court) and not produced the community certificates issued by the revenue authorities there was no other go but to recommend the Government to reject the admission of the withheld students. The students and parents who appeared before the committee were panic and very much mentally disturbed due to the indifferent approach from the part of the college authorities and they expressed their anguish.
9. As the students produced the certificates issued by the competent revenue authorities, for safeguarding the interest of the students the committee decided to reconsider and revise the earlier order of the committee and to recall the order no. AFRC 100/18/BDS/PCDS dated 21.10.2019, recommending the Government to reject the admission of the above 3 students.
10. The approach of the college was highly objectionable and has to be dealt with seriously, as not only the students and parents were pushed to severe mental agony and strain but also to the committee. The Government may consider as to whether a fine can be imposed on the college as per the section 8 (4) of the Act 15 of 2017 for the indifferent action from the part of the college.

11. In view of the above fact situation, the Order No. AFRC 100/18/BDS/PCDS dated 21.10.2019 issued by this committee recommending Government for the rejection of the admission of the 8 students mentioned in Annexure I is recalled. The Government may not proceed on the above order. The Committee will be issuing fresh approval order on the basis of the certificates produced by the students obtained from the revenue officials to prove that they belong to the Syro Malankara Community.

ORDER

1. The Admission Supervisory Committee by order dated 21.10.2019 has approved the admissions of 9 candidates and recommended to Government for rejecting the admission in respect of 3 candidates as per the Annexure I & II of the above order.
2. Thereafter, the 3 students whose admissions were recommended to Government for rejection have appeared before the committee with the community certificates to suit the seat matrix approved by the Government.



3. At the time of submission of documents, the recommended for rejection candidates and their parents have submitted that they were not aware of the withheld status of their admissions and directions in the Hon'ble High Court Order and the College authorities of the Pushpagiri College of Dental Sciences, Thiruvalla, have informed them only after their admissions were recommended for rejection by the Committee to Government.
4. The ASC scrutinised the entire documents submitted by the above 3 candidates and found that certificates obtained from the revenue officials are as per the seat matrix approved by the Government. The grievances and the mental agony faced by the above students and their parents were explained before the Committee.
5. Considering the above aspects, the Committee decided to recall the orders issued on 21.10.2019 for recommending the rejection of the admissions of the 3 candidates to the Government and to approve the admissions of the 3 candidates. The Committee also viewed the indifferent attitude of the Dental College and decided to recommend Government to impose a fine for their impertinent approach.
6. Accordingly, The ASC has issued an order dated 06.11.2019, referred as 3rd paper above, recalling the earlier order of the Committee recommending the Government for rejecting the admissions of the 3 candidates.
7. Therefore, the ASC hereby approve the admissions of the following 3 candidates also for BDS Course against Pushpagiri College of Dental Sciences, Thiruvalla.



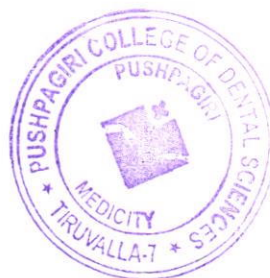
